Sharon Taylor	Sharon discussed how some families are scrambling to figure out issues of children who have recently gone back to MCFD, but have upcoming birthdays and will be turning 19 within the next 6 months.
Barb Warkentine	Barb gave us an update on the PG Therapeutic Riding Association, they have been serving the area for almost 17 years and in the last 3 have been a registered society.
Colleen Hermanson	Colleen is one of our new Council Members; she did not have an update at this point.
Ernie Harding	Ernie updated on the Recycling Program – Bottle Depot, it has been in business for the last 6 years.
Ryan Taylor	Ryan spoke about Individuals who have lost jobs in Fort St. John and the fact there are not many employment opportunities as there are few businesses who hire people with disabilities.
Stephen Russell	Stephen complemented the Council on a great job and thanked everyone for the opportunity to have been asked to join us for these meetings.
David Johnston	Due to past experiences, similar situation as with Fort St John, where there are few employers willing to hire persons with disabilities – not willing to hire and do on the job training, you must have the skills do to the job, how do you get skills if no one will hire you.
Cathy Mortensen	Cathy is also a new Council member, she did not have an update at this point.
Ruth Stanton	Ruth attended the March Employee’s breakfast – they had a guest speaker from Saskatchewan who gave a talk on success stories regarding Individuals working in real work situations with city employees doing mechanic work, cleaning, etc. They were individuals who have MS, Down Syndrome and various other difficulties. Ruth and 3 other Self Advocates lead a session in Vanderhoof, what being a Self Advocate is all about. There were 13 individuals plus family members in attendance. Ruth also let us know they finally got their bus shelter for the bus stop in front of the AimHi building after 1 ½ years. Ruth is also featured in February’s copy of “The Citizen”
Jackie Allen	Appreciated this weekend and the learning opportunities, she has a few names she will contact in Fort Nelson who would make good Self Advocates – she will give them information on what they need to know.
Kris Zemlak	Kris updated us that AimHi is now in partnership with Value Village and

AimHi will so be getting a “bin” at their site for drop offs as well as at the Value Village outlet. They are fund raising, having training sessions on Community Awareness, focusing on the Home Share Program and developed a pamphlet – Kris to bring some to the May meeting.</p> <p>Ann updated us on the issues regarding individuals who are seniors and entering the Seniors Lodge. There is a 1-8 ratio and there are concerns some of our seniors will not have the care and attention they require, a recommendation may be for those staff to have geriatric training. Bonnie Fallowfield has information and will pass this on to. AimHi also has an Aging Committee and Kris will supply us with information.</p> <p>Pat has been appointed to the Prince George Accessibility Advisory Committee. The committee is mandated to bring citizen’s concerns to them. Pat’s appointment starts in April.</p> <p>Terry informed the Council she is now a member of the Provincial Advisory Committee – her first meeting will be March 30th and 31st. PAC meets 4 times per year, Terry will give an update at the next Council meeting.</p> <p>Bonnie discussed the transit buses continue to be an issue in Quesnel – they would like to see the hours extended so individuals who work in the evenings have a safe way home. The local bowling alley will not store the ramp used for bowling, Bonnie is looking into other agencies/user groups who may be able to help advocate to have the ramp stored at the bowling alley so that they could use it also. Quesnel is having the same job issues as Fort St. John. Bonnie also discussed the IF workshop and transitioning youth from MCF to CLBC.</p>
