| Managers Report – Pat | <p>Pat discussed the Giving in Action and FIF (Family Independence Fund). This is a very easy process for anyone who has been determined DD eligible to apply for these funds. Pat also discussed the Federal CMHC forgivable grant up to \$20,000. Low income is the only criteria for this loan based on renters’ income not on Landlords income. She discussed the staff meeting with Malachy Tohill, Regional Manager, BC Housing. BC Housing is a Crown Corporation who manages 3500 units in the North that provides housing for the homeless, Non-Profit, low income families, seniors, disabled and anyone who needs help. They have been given direction to prioritize our folks seeking accommodation. There are very few single living options- more homes with 4-5 bedrooms, members feel no one on PWD can afford this. Assisted living was discussed but this falls under Health and is not ours. It was requested to have Malachy’s assistant, Stacey Kyriakos, attend a future council meeting.</p> <p>There were discussions on having the BCH contact names in each community, housing discrimination; “assisted animals” allowed in homes, will there be modular homes available?</p> <p>Ann P. discussed the 24 units in Terrace – are any of them single unit? Will there be any modular homes? Who is the BC Housing person in Terrace.</p> <p>Housing Discrimination – our individuals not approved to rent, pets (as in Assisted Animals)</p> <p>Earnie discussed the block of housing behind Kal Tire in Smithers – Alpine Court – only 1 unit is accessible - is this correct?
