Guest Speaker - Jule Hopkins, Manager, Service Accountability and Safeguards - CLBC Headquarters</p> <ul style="list-style-type: none"> <li>• Jule gave an overview and discussion regarding CLBC's strategic direction on aging.</li> <li>• Would like forums on aging in conjunction with the Community Council. A great opportunity for Community Council to be involved and host forums on this subject.</li> </ul>		

	<ul style="list-style-type: none"> <li>To plan community forums on aging inviting service providers, home share providers, family members, senior citizens, and various community partners.</li> <li>The goal is to gather information within the various communities.</li> <li>Three questions to ask: <b>What are the challenges experienced as you age, what has worked well and what are your needs?</b></li> <li>To hand out brochures, interviewing individuals, newspaper ads and posters. Everyone unanimously agreed that the brochures are a great tool and more are available.</li> <li>Jule stated there is no timeline and although flexible, a goal is to have an action work plan no later than May 2011.</li> <li>Jule stressed that the forums would be about information gathering only, getting connected, to listen and ask questions.
