

# Residential Services: Individual Financial Payments

Community Living BC (CLBC) provides supports and services to eligible adults\* and their families. CLBC has an Individual Financial Payment Policy that provides information about the monthly amount your family members will pay for shelter and support when required. This information sheet answers some common questions about this policy.

## Why does my family member have to contribute towards their shelter and support?

Individuals living in their own homes pay their rent and basic living costs and individuals supported by CLBC that live in home sharing or staffed residential arrangements do the same.

## How does CLBC decide the monthly amount that individuals pay for shelter and support?

An individual's shelter and support monthly amount is determined based on their income. For individuals receiving the Persons with Disability Assistance (PWD), the monthly amount is based on the PWD rate. For individuals age 65 and over, the monthly amount is based on the Old Age Security and Guaranteed Income Supplement (OAS/GIS) rate.

## Why does my family member's shelter and support rate change when they turn 65?

Your family member receives a higher income once they are eligible for OAS/GIS benefits. CLBC uses the minimum rate set by the Ministry of Health for those receiving OAS/GIS benefits. Support and shelter costs for those receiving PWD benefits are based on the amount of assistance they receive from the Ministry of Social Development, which is lower than OAS/GIS.

*\* A CLBC eligible adult is a person who is 19 years of age or older and who meets the eligibility criteria described in the Eligibility for CLBC Supports and Services Policy.*

## What are PWD funds to be used for?

PWD funds are used for the purposes set out by the Ministry of Social Development - for the support, shelter, personal and basic living costs for the person who receives PWD. For more information about how PWD funds may be used, please contact the Ministry of Social Development.

# Residential Services: Individual Financial Payments

Community Living BC's Individual Financial Payment Policy provides information about the amount you pay for shelter and support. Below is some information about why you pay for shelter and support and how much you have to pay.

## Why do I have to pay for shelter and support?

People who live in their own houses pay rent and other basic living costs (often called shelter and support). Individuals supported by CLBC who live in home sharing or group homes do the same. The amount that you pay is based on your income.

Everybody who receives the Persons with Disability Assistance (PWD) pays the service provider \$716.00 per month towards their shelter and support costs, and they keep \$190.00 per month for personal expenses.

Single individuals who receive the Old Age Security and Guaranteed Income Supplement pay the service provider \$1,005.80 per month towards their shelter and support costs, and they keep \$338.32 per month for personal expenses. Married individuals may pay a prorated rate based on their joint OAS/GIS entitlement.

People who receive OAS and GIS benefits have a higher income than people who receive PWD, so they pay a higher amount for shelter and support for CLBC residential services.
