Nov 25 2009	Acceptance of agenda and approval of last meeting's minutes	Since there was not a quorum present, the minutes could not be approved.

Nov 27 2008	MCFD Summary Document and Children Transition	<p><b>Nov 27</b> – Community Council members requested that an MCFD Summary Document be distributed to have consistent information. The ask will be sent to MCFD headquarters, Ken Kabool and will email Glen Campbell. D. Appleby put forward motion to request the Summary Document, J. Jordon seconded, all in favour.</p> <p><b>Jan 28</b> – WIP – The children's transition is still planned for October 2009. Three people now make up a Governance Committee to ensure everything moves forward smoothly. MCFD wants all of the service provider contracts in their name by April 1, 2009. Staffing details have been mostly worked out. There will be seniority, holidays, vacations, etc. It is the same union. Staff preferencing has not happened yet, however priority will be given to previous MCFD staff and the location to where they are already. Offices being transitioned to CLBC/MCFD still to be decided.</p> <p><b>Apr 29</b> – WIP</p> <p><b>May 27</b> – WIP – There was no new news to announce.</p> <p><b>Jun 15</b> – WIP – No new news to announce on the transition. Currently CLBC cannot accept any new CIC's (Children in Care) as there is no funding for this. CLBC is looking at options to see what they can do if it happens. Emergency cases must be sent to Head Office. The hope is that once the children go to MCFD, they will help this issue.</p> <p><b>Nov 25</b> – CLOSED – CLBC and MCFD funding is completely separate. About half of the CLBC staff have gone to MCFD and have physically moved, however the Port Moody Office is being shared at the moment. Soheila has hired 4 new staff and are discussing moving forward successfully with an adult focus. Letters will be in the mail to parents and caretakers to let them know of the changes. Mar 4 2009	New \$52M funding	<p><b>Mar 4</b> – The 52M is going to be distributed over 2 years. This year there will be 23.4M and CLBC will report to the Minister each month on how the funding will be used. A finalized budget will be done by the end of May and council input will be requested.</p> <p><b>Apr 29</b> – WIP – Fateh presented the Expenditure Plan (S. Rees to scan and distribute with minutes). Of the 52M, Simon Fraser received 2.8M for this fiscal year, 4.3 for next year and is distributed over the next 3 years for Adult Services. Most of the money is planned to alleviate the waitlists and some will be reserved for emergencies.</p> <p><b>May 27</b> – WIP – Individual families on the waitlists were contacted without ‘false’ promises and this is why there are still to be confirmed.</p> <p>In the budget handout, F. Esmail thinks that the recoveries is a transfer of funding and to do with contractor services and will verify for the next meeting.</p> <p><b>Jun 15</b> – WIP –</p> <p>F. Esmail confirms from the last meeting that the reason the children budget recoveries is higher in 2010 than 2009 due to the recoveries from MCFD.</p> <p><b>Nov 25</b> – CLOSED – Currently everyone who has been on a waitlist has received something. It looks like there is a surplus in the budget, but it will be spent.</p>

May 27 2009	Improved Eligibility	<p>Currently the Government is looking to expand services to those who do not currently qualify. They are in the early stages of discussion to set the eligibility criteria and no resolution expected for a few months.</p> <p><b>Jun 15</b> – WIP – More discussion will be needed. Currently this project is to identify the need and what they can provide for individuals with an IQ over 70.</p> <p><b>Nov 25</b> – WIP – Soheila is hiring someone to support this new area and criteria. There is a small amount of additional funding of 8M for this for the entire province. Data for who are and aren't accepted for these new qualifications will be tracked. A certified phycologist will be supporting this, however the agreement isn't complete yet. Soheila will send out more information when she receives it. Funding won't go through until February 2010 and new staff will need to be hired and trained.</p>
