1. Call to Oder:

2. <u>Minutes of the Board Teleconference - September 11, 2007</u> *Motion*

3. Adult Community Living Research Project

Brian Salisbury introduced Dr. Tim Stainton and Leah Wilson, from the School of Social Work, University of British Columbia. Dr. Tim Stainton is researching the current state of practice with regards to community living services in BC in the areas of young adults transitioning from high school, residential options, non-residential supports and services for seniors. The researchers presented some of the partial results and informed that the study will be finalized in the summer 2008.

4. Crisis Response

Brian Salisbury presented the document "Enhancing Community Capacity to Respond to Crisis". The document is a guide to be used by anyone that wants to explore new ways to respond to a crisis. This work is the result of a number of community discussions led by Dan Collins, Executive Director of Langley Association for Community Living and Brian Salisbury.

Carla Thiesen presented the document "Crisis Response Plan" for Surrey/Richmond/Delta and informed that CLBC has been working on this issue since 2004 (as Interim Authority). Part of this work included contracting an external partner to assist to explore approaches to crisis response. A Steering Committee of community partners is developing a two year plan.

5. Standards for Home Sharing

Andrea Baker presented the report "Standards for Home Sharing", "Health and Safety Checklist for Home Sharing" and "Monitoring Tool for Home Sharing". The standards are divided in four domains: planning; health, safety and advocacy; service delivery; and resources.

This year the focus will be on training and information sharing with our Home Sharing Providers.
